1. A tenderer must not comprise any company incorporated in British Virgin Islands. Any company incorporated in British Virgin Islands is not eligible for submission of tender.

Any tender must be made in the Form of Tender (in prescribed form) signed by the tenderer which together with other relevant tender documents shall be enclosed in a sealed plain envelope and placed in the specified Tender Box located at 23/F, Pioneer Centre, 750 Nathan Road, Mongkok, Kowloon from 11:00 a.m. on 6 June 2017 to 12:00 noon on 6 June 2017 (“Tender Closing Time”).
