在某人就指明住宅物業與擁有人訂立臨時買賣合約時，該人須向擁有人支付售價的 5% 的臨時訂金。

A preliminary deposit of 5% of the purchase price is payable by a person to the owner on entering into a preliminary agreement for sale and purchase in respect of the specified residential property with the owner.

如某人於某日期訂立臨時買賣合約，並於該日期後的 5 個工作日內，就有關住宅物業簽立買賣合約，則擁有人必須在該日期後的 8 個工作日內，簽立該買賣合約。

If a person executes an agreement for sale and purchase in respect of the residential property within 5 working days after the date on which the person enters into the preliminary agreement for sale and purchase, the owner must execute the agreement for sale and purchase within 8 working days after that date.

If a person does not execute an agreement for sale and purchase in respect of the residential property within 5 working days after the date on which the person enters into the preliminary agreement for sale and purchase - (i) the preliminary agreement is terminated; (ii) the preliminary deposit is forfeited; and (iii) the owner does not have any further claim against the person for the failure.

2. 成交金額 5% 即加付訂金於買方簽署買賣合約時繳付。
3. 成交金額 90% 即成交金額餘款於買方簽署臨時買賣合約後 60 天內繳付。

##### **(A) Cash or Immediate Mortgage Payment - 2% discount from the Price**

1. A preliminary deposit equivalent to 5% of Transaction Price ("Preliminary Deposit") shall be paid upon signing of the preliminary agreement for sale and purchase.
2. 5% of the Transaction Price being further deposit shall be paid upon signing of the agreement for sale and purchase.
3. 90% of the Transaction Price being balance of Transaction Price shall be paid within 60 days after signing the preliminary agreement for sale and purchase.

##### **(B) 180 天靈活付款 - 照售價**

1. A preliminary deposit equivalent to 5% of Transaction Price ("Preliminary Deposit") shall be paid upon signing of the preliminary agreement for sale and purchase.
2. 5% of the Transaction Price being further deposit shall be paid upon signing of the agreement for sale and purchase.
3. 90% of the Transaction Price being balance of Transaction Price shall be paid within 180 days after signing the preliminary agreement for sale and purchase.

1. A preliminary deposit equivalent to 5% of Transaction Price ( “Preliminary Deposit” ) shall be paid upon signing of the preliminary agreement for sale and purchase.
2. 5% of the Transaction Price being further deposit shall be paid upon signing of the agreement for sale and purchase.
3. 90% of the Transaction Price being balance of Transaction Price shall be paid within 128 days after signing the preliminary agreement for sale and purchase.

買方可獲額外售價 2%折扣優惠作為「管理費津貼」優惠。  
[Management Fee Subsidy] Benefit  
An extra 2% discount from the Price would be offered to the purchaser as the [Management Fee Subsidy] Benefit.
- (d) 「置業大禮」折扣優惠  
買方可獲額外售價 3%「置業大禮」折扣優惠。  
[Home Purchase Offer] Discount  
An extra 3% discount from the Price would be offered to the purchaser as the [Home Purchase Offer] Discount.
- (e) 「從價印花稅津貼」優惠

[Ad Valorem Stamp Duty Subsidy] Benefit  
An extra 6.5% discount from the Price would be offered to the purchaser as the [Ad Valorem Stamp Duty Subsidy] Benefit.

**Any gift, or any financial advantage or benefit, to be made available in connection with the purchase of a specified residential property in the development:**

In addition to the payment benefits and discounts on the price mentioned in 4(i) and 4(ii), the Purchaser(s) who choose Payment Plan (A), (B) & (C) stated in 4(i) may apply to the Vendor's designated financing company for the Second Mortgage Loan. Key terms are as follows:

**「成交金額 30% 第二按揭」優惠(由「經絡按揭」安排)**

買方可由「經絡按揭」安排之財務機構/銀行(「安排之第二承按人」)申請最高達成交金額之 30% 或物業估價(由安排之第二承按人釐定)之 30%(以較低者為準)之第二按揭(「第二按揭」)，一按加二按總貸款額合共不超過成交金額之 80% 或物業估價之 80%(以較低者為準)，第二按揭最高貸款金額為港幣 300 萬元。第二按揭及其申請受以下條款及條件規限：

**The benefit of “second mortgage for 30% of Transaction Price” (Arranged by mReferral Mortgage Brokerage Services)**

The Purchaser may apply for a second mortgage through the financial institution/bank (the “Arranged Second Mortgagee”) arranged by mReferral Mortgage Brokerage Services for a maximum loan amount equivalent to 30% of the Transaction Price or 30% of the valuation of the property (as determined by the Arranged Second Mortgagee) (whichever is lower) (the “Second Mortgage”). The loan amount of the first mortgage and the Second Mortgage shall not exceed 80% of the Transaction Price or 80% of the valuation of the property (whichever is lower).
